#### **Member Training Update**

For those members who need or want the new TCT (Team Coordination Training) refresher course, it is being offered three more times. First, it is being offered locally at the Clearwater flotilla classroom on Sunday, August 11 at 1400. You need to sign up soon as class size is limited, and some spots are already filled. Due to vacation schedules, the deadline thru me (as FSO-MT) is July 27th. From then thru August 7th, final deadline, you would need to sign up thru Rob Bonnem as VFC.



The other opinion is to take it in Orlando at either NACON on August 24 at 1300 or DTRAIN tentatively scheduled on September 22 at 0800. Either class will require you to pay to register for that conference and go to Orlando.

The course is required for some members but any member who has thoughts of working for the Marine Safety Office (MSO), getting into any operations area such as boat crew or becoming a Telecommunications Operator (TCO) should take it as well.

Show up, sign in, participate and you have completed it for this year. If you have already completed the course then tell another member how easy it is and how they can become more involved.

Remember that you need to have completed the Introduction to Risk Management Course before taking TCT. The Risk Management course is available online.

### Clearwater Air Station C-130 Update



As reported in a previous Newsletter, John Tassinaro retired from his Auxiliary duties at the Coast Guard Clearwater Air Station after ten years. He was the main person who would maintain the Garman and Jeppessen flight maps loaded into the C-130s. He served in this capacity

from January 2009 to January 2019. Joan Gutek was his backup but didn't get to do it very often since John was there all the time.



Currently, Gordon Thomas and Joan Gutek (both of Dunedin flotilla 11-10) have now taken over those responsibilities. Flight maps for Garmin and Jeppessen must be download almost every week to all four C-130s. It is a highly computerized time critical event which often runs up against glitches that must be handled.

Since this can take up lots of time, having the two of us makes the job flow more easily over the week. We start working with this on Tuesday and if lucky, finish by Wednesday. More often than not, planes are deployed days at a time or are busily going out a few times during the same day resulting in incomplete downloads to their devices. Therefore, our job sometimes requires one of us to come back later at night or later in the week to get the final updates loaded.

We are also responsible to make sure that connections are working properly especially the antennae and have them replaced or fixed as needed. Computer glitches must be solved on the fly especially if a plane is needing to deploy.

Occasionally more reticent problems must be worked out with the software companies tying up much time.

We are always looking for qualified instructors to help teach our popular About Boating Safety and Basic Skills and Seamanship Classes.

It's easy to qualify as an instructor by completing the Instructor Development Course (IDC) and allows members to participate in another of the primary missions of the Coast Guard Auxiliary. The Instructor (IT) certification will allow you to participate in the promotion of recreational boating safety through Public Education and to instruct in the many Auxiliary Member Training courses. The course is conducted by an IT mentor working with the trainee to pass an open book exam and successfully complete Performance Qualification System (PQS) tasks. Following the completion of PQS tasks, the trainee will be required to conduct training events in accordance with the IDC course material. A certified mentor instructor will evaluate the event presentations. Course material is available from ANSC or can be downloaded by visiting the National Education Department website.

#### **Coast Guard Auxiliary Eightieth Anniversary**



When the Coast Guard "Reserve" was authorized by act of Congress the Coast Guard was given a legislative mandate to use civilian volunteers to promote safety on and over the high seas and the nation's navigable waters. The Coast Guard Reserve was then a non-military service comprised of unpaid, volunteer U.S. citizens who owned motorboats or yachts.

Two years later, on Feb. 19, Congress amended the 1939 act with passage of the Auxiliary and Reserve Act of 1941. Passage of this act designated the Reserve as a military branch of the active service, while the civilian volunteers, formerly referred to as the Coast Guard Reserve, became the Auxiliary.

February 19 is formally recognized as the birth of the Coast Guard Reserve while June 23 is recognized as birthday of the Coast Guard Auxiliary.

When America entered World War II, 50,000 Auxiliary members joined the war effort. They guarded waterfronts, carried out coastal picket patrols, rescued survivors from scuttled ships and did anything else they were asked to do. Many of their private vessels were placed into service.

After the war, Auxiliarists resumed their recreational boating safety duties. The Auxiliary's four cornerstones--Vessel Examination, Education, Operations and Fellowship--were established and remain the Auxiliary's pillars today.

#### Today's Auxiliary

Auxiliarists continue to be a vital part of the Coast Guard. Under legislation passed in 1996, the Auxiliary's role was expanded to allow members to assist in any Coast Guard mission, except direct law enforcement and military operations, as authorized by the Commandant.

Thus, Auxiliarists can be found examining commercial fishing vessels, flying in C-130 aircraft, working in Coast Guard offices, and crewing with regulars. The three components of the service–the active duty Coast Guardsmen, the Reservists, and Auxiliarists–truly constitute TEAM COAST GUARD.



#### **Auxiliary members:**

- Perform free Vessel Safety Checks, which helps boaters ensure their craft complies with Federal boating regulations.
- Teach boating safety to recreational boaters of all ages.
- Operate safety and regatta patrols and are an integral part of the Coast Guard Search and Rescue team.
- Stand communication watches, assist during mobilization exercises, perform harbor and pollution patrols, provide platforms for unarmed boarding parties.
- Recruit and can provide initial training for people
